Introduction

Thank you for taking the time to learn how to strengthen your business practices! Having the right resources is key to running a successful small business. Whether you currently run a family child care home, or are just starting a new program, this Child Care Business Guide will give you the information and resources you need to succeed. This guide will focus on information that is most relevant to a family child care home business. For information about running a child care center, see the <u>Business Guide for Child Care Centers</u>.

The Colorado Department of Early Childhood knows that running a small business, especially a child care business, is hard. Most child care providers entered this profession because of their love for working with children, not their love for accounting. Still, strong business skills are necessary to keep your business open so you can continue doing the work you love.

Because the early care and education you provide is so important to the children and families you serve, your community, and our state, we wanted to make the business side of your work easier. We hope this guide will be a useful tool to do just that. Here's what you can expect from the guide:

- Easy to navigate table of contents: We know you are short on time. We want you to be able to jump to the exact information you need. You can use the table of contents to navigate the document, or press Ctrl + F to search for a specific term in the guide.
- A number of business-related topics: Since this guide is designed for new and existing providers, it includes topics to help establish, sustain or expand a child care business.
- High-level content: For each topic, we include key points you should know or consider as a small business owner. We'll also provide links to more information and resources in case you are interested in diving deeper into a topic covered here.
- Regular content updates: This guide will be a "living document." It will be updated at least annually with new information and resources as they become available.

Before we begin, let's review some vocabulary you'll encounter in the guide. Most providers know the difference between these terms. However, we wanted to provide basic definitions for the following words so they have the same meaning for everyone:

- Child(ren) = the students you serve in your program
- Facility = physical structure (building or home) where early care and education takes place
- Program = a licensed family child care home or licensed child care center
- Provider = operator of a licensed family child care home or licensed child care center
- Staff = teachers or assistants in a licensed child care center or licensed family child care home

Child Care Licensing and Quality Ratings

If you are just starting your child care business, or if you are considering changing your license type, it is important to know all your options so you can determine which license type is right for you. The Colorado Department of Early Childhood issues child care licenses and determines the requirements for each license type. The license type you choose will impact the ages of children that you can serve, how many children you can serve, and how many staff are required to supervise the children. These limitations are necessary to ensure the health, safety, and wellbeing of the children in care.

Child care businesses must figure out how to earn enough money given these rules. You should plan to meet with a Child Care Licensing Specialist to discuss options for your child care business before you apply for a child care license. Child Care Licensing Specialists can help you understand how to design your space to meet child care licensing requirements. You can register for a free one hour orientation to learn more. Register under the "Apply for a Child Care License" section of the CDEC website. It is recommended that you apply for a child care license 60-90 days before you intend to open your child care program.

Below is a list of the license types and enrollment capacity rules for licensed family child care homes. Ensure you check the CDEC website for the latest <u>child care licensing rules</u>. If you would like direct CDEC email updates on child care licensing changes, you can <u>sign up</u> here. If you are interested in becoming licensed or changing your license type, follow the links provided in the last bullet of each section:

NOTE: STATEWIDE WAIVER: Two Children Under 18 Months: Starting December 15, 2021, the Colorado Department of Early Childhood (CDEC) will be providing a statewide waiver for licened family child care home providers as an emergency relief effort to support families struggling to find infant and toddler care throughout the state. Licensed providers will not be required to submit any additional paperwork to utilize this option. The family child care home waiver reduces the current age requirement that allows a licensed provider to care for 2 children under 2 years of age to now care for 2 children under the age of 18 months. Ready more about how it impacts each family child care license type here.

Family Child Care Home

- Regular Family Child Care Home: One provider serves up to six children, of which only two can be under 2 years old. An additional two school-aged children may be served during non-school hours for a maximum group size of eight.
- Three Under 2 Family Child Care Home: One provider serves up to six children, of which only three can be under 2 years old. However, no more than two children can be under 1 year old, and care of additional school-aged children is not authorized.
- Infant/Toddler Family Child Care Home:
 - One provider serves up to four children under 3 years old, of which only two can be under 1 year old.
 - Two providers serve up to eight children under3 years old, of which only four can be under 1
 year old.

Large Family Child Care Home:

- One provider can serve up to eight children, of which only two can be under 2 years old.
- Two providers can serve up to 12 children, of which only two can be under 2 years old.
- Experienced Family Child Care Provider: Varies, but largest capacity is for nine children. Providers must be licensed for six years before they can apply.
- To apply to be a family child care home or change license type, review this <u>training requirement</u> <u>document</u> and then use <u>this guide</u> to apply.
- NOTE: In Colorado, there are limited instances in which a program (both family child care homes and child care centers) can operate without a child care license, called legal exemption or license-exempt. Please read this information on what types of programs may qualify.

Building Requirements and Child Care Licensing Contact Information

Prior to operating your family child care home, you should review these resources that explain what needs to be in place once you do start operating. Being familiar with these requirements early will ensure you set up a successful program. They will also help you prepare for child care licensing inspections once you become licensed:

There is now a <u>Colorado Department of Early Childhood Provider Hub</u> where you can manage your child care licensing profile for the Colorado Shines parent search function, Quality Rating and Improvement System, Attendance Tracking System for the Colorado Child Care Assistance Program, and certain state grants in one place. You will learn more about these programs below.

Colorado Shines - Quality Rating and Improvement System

A key way to ensure you have full enrollment in your child care business is marketing the quality of your program to families. Many states have implemented a Quality Rating and Improvement System (QRIS) to help define quality for licensed child care programs. Colorado Shines is the official name of Colorado's QRIS. Colorado Shines rates the quality of Colorado's early learning programs, on a scale of one to five, based on how well the program:

- Supports children's health and safety
- Ensures staff are well-trained and effective
- Provides a supportive learning environment that teaches children new skills
- Helps parents become partners in their child's learning
- Demonstrates good leadership and business practices

Once your program becomes licensed (and automatically achieves Level One status), you can receive support from Colorado Shines Quality Improvement Coaches located at <u>Early Childhood Councils</u> to improve your quality rating.



Having strong business practices is one way to earn points. This includes having a business or strategic plan, having an operating budget, and more. Earning a higher Colorado Shines rating can signal to families that you are committed to offering a quality early learning experience for their children. It also opens up additional grant opportunities for you as a provider.

In addition to helping with marketing, this rating system also influences the reimbursement rates for Colorado's child care subsidy program, Colorado Child Care Assistance Program. We will talk about that more in the "Financials" section.

Successful Business Planning

Part One - Address the Requirements to Open a Family Child Care Home

Rental Agreements & Homeowners' Associations (HOAs)

If you are renting, you should check with your rental agreement and your landlord to see if you are allowed to operate a family child care home from your residence.

If you own your home, you should check your neighborhood covenants or Homeowners' Association (HOA) documents prior to applying.

Please note that Colorado law states that Homeowners' Associations are not allowed to prohibit operation of a licensed family child care home in the community.

The HOA is allowed to have regulations that apply to all residences around issues like noise or parking. As a family child care home provider, you should be aware of these regulations. However, the HOA must make reasonable accommodations to typical community regulations so that a family child care home can meet the child care licensing requirement of having a fence. Additionally, the HOA is allowed to require the family child care home to carry a reasonable amount of liability insurance (see the section on Business Insurance below). This law is not applicable if your home is in a community qualified as housing for older persons per federal law. Read more about the law here.

▼ Zoning and Fire Code

All license types (except those based out of school buildings) are required to have zoning approval from their local building planning and zoning department (it may be called a Regional Building Department, Development Services, Building Inspections, Building Services, Community Planning and Development, Building and Land Use, etc.). They can provide more information about what is regulated in your area. Keep in mind that zoning approval can take time (sometimes up to six weeks or more), so it's best to contact your zoning department early in the process of becoming a licensed family child care home.

Fire codes are managed locally. Family child care homes may not need to complete a fire inspection. Please visit your local zoning and planning department for the most accurate information about how to meet fire codes for your child care business. Your Child Care Licensing Specialist can also help you find this information.

Please note that, effective October 2021, Colorado law states that local governments must treat family child care homes as residential property when it comes to local regulations like zoning, land use development, fire and life safety, sanitation, and building codes.

This means that no additional local regulatory requirements can be placed on family child care homes beyond what applies to any private home, with one exception. The exception is that a local government may, on a case-by-case basis, prohibit operation of two or more large family child care homes immediately next to one another. They may also regulate traffic or parking for those providers. You can read more about this law here.

▼ Background Checks

You, as the family child care home provider, any staff working with you, and any residents of your home must complete the background check process prior to opening your family child care home. For the most up-to-date information on required background checks, visit the <u>Background Checks</u> page on the CDEC website. Here is <u>a video</u> that provides an overview of the background check process.

New providers must complete the following:

- Colorado Bureau of Investigation/Federal Bureau of Investigation (CBI/FBI) fingerprint-based background check NOTE: new providers must first complete all relevant Family Child Care Home Application documents and training and submit the child care licensing package and fee to the Division of Early Learning Licensing and Administration, CDEC before they complete the background checks. After these steps, they will be assigned a license number and sent an email with detailed instructions on how to complete their CBI/FBI background check.
 - Who must complete it?
 - every person applying for a family child care home license;
 - every adult over the age of 18 who lives in the home;
 - every person over the age of 16 that will take care of children in the family child care home; AND
 - any adult over the age of 18 that moves into the home (i.e. adult children moving back home, roommates, etc.), or any adult that comes into contact with children (substitutes, volunteers, etc.).
- Trails background checks This is a check of the Colorado Department of Human Services' (CDHS) Trails database for confirmed reports of child abuse or neglect. This check is done with the processing of the Family Child Care Home application for all individuals living in the home, regardless of age. Any individual that does not reside within the Family Child Care Home, but will assist with the care of children, must submit a Trails database request either through the typewritten request form or through the Provider Hub, as well as submit the appropriate fee.
- Other state background checks If the applicant has lived outside of Colorado in the past five years, they will be subject to more background checks associated with each state. This process can be started before receiving a license number from the state.
 - Who must complete it?
 - every person applying for a family child care home license who lived outside of Colorado in the previous five years; AND
 - every person over the age of 16 that will care for children in the family child care home who lived outside of Colorado in the previous five years; AND
 - everyone living in the family child care home over the age of 18 who lived outside of Colorado in the previous five years.

Existing family child care home providers must complete the FBI check every five years.

If you employ a staff member, FBI and Trails background checks for them must be kept on file at all times and for a minimum of three years after employment has been terminated.



For family child care homes, if you hire a new staff member who previously worked for another program, be aware that they may have to submit new fingerprints if separated from employment for more than 180 days as the fingerprints are attached to a license number. If the new employer is the same governing body then the CBI, FBI, and Trails checks are portable which means they do not have to resubmit new background checks unless it's time to meet the five-year requirement for FBI and Trails.

There is a cost associated with the background check process, so providers that hire staff or have additional family members that reside at the program location should address these costs in their budget. For Criminal Background Investigation Help contact cdec_cbc_biu@state.co.us or call 303-866-5043. Please note that processing background checks can take time. It sometimes takes four to eight weeks or even more. Plan for that in your business operations.

✓ Health Requirements

Prior to operating a family child care home, you must have a medical provider complete the health evaluation form for you and any residents of your home, whether they are children or adults. This form must be kept on hand in your home to show to child care licensing, but it does not need to be submitted as part of the application. The health evaluation form must be renewed every two years (or as frequently as required in a written plan signed by a physician or other health professional) for you (the provider), children living in the home less than twelve years old, and any person that is caring for children.

Part Two - Set Up a Strong Business Structure for Your Family Child Care Home

▼Legal Structure

Legal structures for family child care homes will determine liability, how you pay taxes, as well as other things, such as if you can access certain types of grants.

Family child care homes automatically operate as sole proprietorships if they do not choose any other legal structure. You may want to consider a limited liability company (LLC) to limit personal liability when running your business. You can read more about <u>sole proprietorship or LLC structures</u> here to decide what makes the most sense for you.

▼Obtaining a Business License

Once you have figured out what type of child care license you will obtain and the legal structure you want to pursue, you should check if your family child care home needs to obtain a business license depending on your city/county requirements. Check with the zoning and planning department in your city or county. It is best practice to obtain a business license, so you may want to obtain one for your family child care home regardless of the local ordinances.

Here is a helpful checklist for new small businesses to obtain a business license.

If you are going to be employing additional professionals, you need to get <u>an employer</u> <u>identification number (EIN) from the IRS</u>. An EIN will prevent you from needing to put your social security number on reimbursement forms for funding programs or for families that have child care savings accounts among other things.

▼Business Insurance

It is recommended to research different types of insurance for your business. The <u>Department of Regulatory Affairs</u> has details about things like business liability insurance, property insurance, workers' compensation insurance, and more. These types of insurance can protect you, your home, and your child care business from financial liability in the event that anything goes wrong related to your child care business.

Business Plan

Creating a business plan will help you understand more about your community, such as population density and birth rate. It will also help you project what your annual revenue and expenses might be, what your cash flow each month will be, what your staffing model will look like for large family child care homes, and more to ensure that your business is successful. Undergoing a planning process might include doing an analysis to identify the strengths, weaknesses, opportunities and threats (<u>SWOT analysis</u>) for your child care business, including, where other child care businesses might be located in relation to yours, how many children under five years of age live in your community, what types of employers (whose workforce might need child care) are in your community, and more.

Small Business Development Centers across Colorado have developed business training programs for family child care homes, child care centers, and programs going through the start-up or expansion process. They have resources on creating budgets, business plans, cash flow projections, and more.

M Budgeting

Budgeting for your program ensures that you are able to set and meet financial goals. This includes setting enrollment projections for your program, and understanding how to set up your fee structure. These are generic templates that can be downloaded and customized to meet your program's needs such as budgeting for consultative supports (e.g. Child Care Health Consultants), and more.

▼Enrollment and Fee Collection

In order to run a successful child care business, there are a few principles to keep in mind. The <u>Iron Triangle</u> is a business best practice to keep in mind as you build your program. It details the importance of full enrollment, full fee collection and creating a model in which revenue covers the actual cost of services per child. ▼Banking, Credit, and Loans

Setting up a separate business bank account for your child care business is important for revenue and expense tracking among other things. To support your child care program in times of fluctuating cash flow, obtaining a line of credit or credit card for your child care business can help you cover extra expenses until your revenue is available to cover those expenses. The Office of Economic Development and International Trade has information about different types of loans or banking institutions that can support child care businesses.

▼ Taxes and Accounting

Child care businesses will have to file taxes on an annual basis just like other types of businesses. However, there are many types of expenses that can be deducted to reduce your tax responsibilities. Record keeping and good accounting are key to track different types of expenses and revenue that support your child care business.

For example, family child care homes should know the square footage of their household and the cost of their rent/mortgage and utilities on a monthly basis, so the percentage of those expenses can be deducted from their taxes. Here is one article on record keeping to help you understand what can be tracked and how long documentation should be kept. Here is another article if you want an additional point of view.

You should reach out to your local family child care home association or the state family child care home association, Colorado Association of Family Child Care, to get suggestions from your peers on tax or accounting professionals that they trust. The CAFCC has a <u>list of local family child care associations</u> on their website. Additionally, Tom Copeland is a trusted resource for many Colorado family child care home providers on various business topics, including taxes and accounting. <u>His</u> website often has helpful tips on such topics.

Human Resources

Family Child Care Homes may have an additional staff member. If you employ a staff member, you should be familiar with labor laws (especially around wages and overtime) and plan to address the following aspects of employment to ensure a successful experience:

- Managing the hiring process such as screening of candidates, interviews, and background checks
- · Onboarding of new staff
 - Create a first day, first week, and a first 30 day plan for new staff to ensure that they
 have access to resources to help them be successful employees
 - · Completing employment paperwork and training requirements
- · Record keeping for staff
 - Staff file checklist template
- · Managing payroll for staff

If a family child care home employs an additional staff member, they are also governed by Occupational Safety and Health Administration (OSHA) and the Americans with Disabilities Act (ADA). Some child management software systems can assist with tracking these requirements. Please see the "Software to Help your Business" section for more information

Health Insurance

The Early Childhood Education Association has established a <u>Statewide Health Plan</u> accessible to anyone in the child care industry, including family child care home providers.

Family And Medical Leave Insurance (FAMLI) Program

Colorado voters approved Proposition 118 in November of 2020, paving the way for a state-run Paid Family and Medical Leave Insurance (FAMLI) program. The FAMLI program will ensure all Colorado workers have access to paid leave in order to take care of themselves or their family during life circumstances that pull them away from their jobs — like growing their family or taking care of a loved one with a serious health condition. Retirement

It's important for family child care home providers to save for their own retirement. For help thinking through retirement plan options, contact your local <u>Small Business Development Center</u> for free consultation.

Substitutes

It is critical for family child care home providers to think in advance about how they will obtain substitute coverage in the event they are out sick or on vacation. Having a plan for this prior to beginning operation and communicating this plan to families will ensure you can offer consistent care and take care of yourself. For family child care homes, child care licensing rules recognize three types of substitutes: an urgent/emergency substitute; a substitute working less than 14 days (or 112 hours) per year; and a substitute working 14 days (or 112 hours) or more per year. Each type of substitute has different requirements which can be found here. Family child care home providers may also want to explore whether an approved licensed substitute placement agency can assist.

✓ Marketing

Once you have your child care business structures in place, it's time to start thinking about marketing your program! Ideally, you will have a website that details your program offerings (hours of operation, teaching philosophy, location of your program, number of spaces in your program, and more). Some software companies for child care programs offer the ability to create a website using their platforms (see the "Software to Help Your Business" section below). You should determine what social media platforms you would like to use both publicly to market your program and privately to share information with enrolled families. Examples include Facebook, Instagram, care. com, Twitter, Yelp, and other platforms where families may search for services. You can also set up a Google account to take ownership of your Google location listing to include business hours and information about your program.

By becoming licensed, you will automatically be listed in the Colorado Shines search database for licensed child care programs in Colorado. Colorado Shines provides a search engine for families that are looking for licensed child care programs in their community. Keeping your Colorado Shines profile up-to-date with your program information is also an important step in helping families find your program. It is free once you become licensed. The newly published <u>provider portal</u> is the best tool for keeping this information updated.

Financials

Covering the Cost of Serving Children

Successful child care businesses often use multiple funding streams to cover the cost of serving their children. You may hear this process of combining funding streams called "blending," "braiding," or the term preferred by Head Start, "layering." You can read more about this concept here.

While relying on additional funding streams can make accounting more complex, it also helps child care businesses protect themselves financially. For example, a recent <u>report by Early Milestones Colorado</u> found that providers who participated in the Colorado Child Care Assistance Program, Colorado Preschool Program, or similar local public preschool programs were more likely to stay open during the coronavirus pandemic. As you review the funding options below, <u>this resource</u> from New York State may help you think through how to combine funding streams for your program.

It is critical to create a business model that is sustainable for the long run, taking into account realistic usage of various available funding streams. It is also very important to distinguish one-time grants (that can support startups) from ongoing sources (below) that can be relied on over time.

Private Pay

- Providers set the amount they will charge families for care.
- To ensure a sustainable business, your private pay rate must be enough to at least cover your operation costs and draw your salary as a home provider. You should consider these costs, including any profit you wish to make, and work backward to figure out what you must charge per child.
- Setting rates may mean that different children will generate different amounts of revenue, so your budget projections will need to take this into account. For example, private pay children will need to cover the cost of services and food that may be included whereas a child that qualifies for the subsidy program may generate a different amount of income. This is why budget projections for both expenses and revenue are important for setting private pay rates. Public Revenue Programs

Colorado Child Care Assistance Program (CCCAP)

What is it?

The <u>Colorado Child Care Assistance Program (CCCAP)</u> is a program administered by Colorado counties for the Colorado Department of Early Childhood. County Departments of Human/Social Services administer the CCCAP locally. Families can access child care assistance through the following options:

- 1. Low-Income Child Care a child care component within CCCAP for households with an adult caretaker or teen parent who is in a low-income eligible activity or income eligible, and not receiving Colorado Works, Child Welfare, or Protective Services Child Care; or
- 2. Colorado Works Child Care a child care component within CCCAP for Colorado Works households with an adult caretaker or teen parent who is determined to be work-eligible per Colorado Works Program rules and have been referred for child care by the county Colorado Works worker; or
- 3. Protective Services Child Care a child care component within CCCAP for children that have been placed by the county in foster home care, kinship foster home care or non-certified kinship care; have an open child welfare case; and the county has chosen to provide child care services utilizing the Child Care Development Fund (CCDF) rather than the Child Welfare Block Grant; or
- 4. Child Welfare Child Care a child care component within CCCAP in which less than 24-hour child care assistance is needed to maintain children in their own homes or in the least restrictive out-of-home care when there are no other child care options available.

CCCAP families need child care in order to continue their employment, higher education, job search, and their move toward self-sufficiency. As a child care provider, you will be working in partnership with counties to provide families access to high quality early care and learning.

What are the program requirements?

Family child care providers participating in CCCAP must:

- · Be licensed and in compliance with Licensing and CCCAP rules, regulations and policies
- Have an open CCCAP Fiscal Agreement with one or more counties and follow the responsibilities listed in the Fiscal Agreement
- Provide the counties with a copy of their private-rates and agree to notify the counties if the private-pay rate changes
- Agree to track attendance through the Attendance Tracking System (ATS)
- Provide the counties with a copy of their provider calendar that includes dates they are open and closed

How do I apply?

- STEP ONE: Reach out to <u>your county department of human/social services</u> to tell them you are interested in becoming a CCCAP provider.
- STEP TWO: The county will send you a packet of information, including the following:
 - Fiscal Agreement: The Fiscal Agreement serves as a contract between you and the county. It outlines the responsibilities, policies, and <u>reimbursement rates</u> between you and the county. If you want to offer CCCAP to families in multiple counties, you must have a separate Fiscal Agreement with each county. Fiscal Agreements renew every three years.
 - The rate of CCCAP reimbursement from the county to the provider varies based on a number of factors: the child's age, amount of care being provided, the type of care being provided, the child care provider's quality rating through Colorado Shines, and the county ceiling rates. The ceiling rate is the maximum county daily reimbursement rate. Providers may be reimbursed up to the ceiling rate for each county, but not more than what is charged to private pay families.

- Full-time rates apply when the child attends more than five hours per day. Part-time rates apply when the child attends five hours or less per day. The part-time rate is based on 55% of the full-time rate
- W-9 Form: This is used to report payments made by CCCAP for tax purposes.
- Provider Calendar: This is used to determine holidays that may be paid by the county and the dates the provider is closed for care.
- **STEP THREE:** Following the instructions from your county, return the completed and signed forms, along with other required information, like your private pay rates.
- STEP FOUR: Once your paperwork has been processed, you will receive CCCAP information along with a copy of your executed Fiscal Agreement and individual Rate Schedule with your CCCAP reimbursement rates. You will also receive information via email on how to register as an ATS user.

What if I'm selected?

The county determines whether a child is eligible for CCCAP. The child remains eligible for CCCAP for 12 months so long as their parent or caregiver continues to be eligible through qualifying activities such as searching for work. At 12 months, a re-determination of eligibility occurs.

Once you are approved as a CCCAP provider by a particular county, you can enroll children participating in that county's CCCAP program. To do so, the parent or caregiver must provide your program information to their county worker, who would then create an authorization for child care with the requested provider. This ensures that payment is made directly to you.

How are providers paid?

Once the child is enrolled, their parent or caregiver must sign them in and out every day using a PIN with the Attendance Tracking System (ATS). This PIN must be entered by the parent or caregiver. Per the Fiscal Agreement, the provider cannot have access to, use or request the parent's or caregiver's PIN. It is important to set the expectation with your families that they enter the PIN every day to ensure accurate billing so you do not lose out on the funding for caring for that child that day. The ATS, which can be run on any internet-capable device, is what triggers payment from the county to you. Payment is based on the days that the child attended the program and the rate of reimbursement you receive for that particular child. You will also receive reimbursement for holidays and the minimum absences paid by each county, per their county plan.

You receive payment from the county every week through automatic deposit. For licensed family child care homes, there is also the option to receive payment on a debit card. Any mistakes made in the attendance or reimbursement process must be addressed through a manual process.

You may also collect a monthly parent fee from the parent or caregiver. The amount of that fee is included in the Authorization Notice from the county. Sometimes, a parent has no fee because they have no countable income. You must determine when you want the parent to pay the fee and collect it directly from them. Parent fee dollars are the first dollars used for care. The provider will not receive any payments from the county until the parent fee has been deducted.

Each county has the option to pay for activity, registration and/or transportation fees. If the county offers these fees, they will be detailed on the Fiscal Agreement Rate Schedule. If a county chooses not to cover these expenses, you cannot charge these fees to the parent or caregiver of a child participating in the CCCAP program. The only exception is if you offer two equivalent age appropriate activities, one that is free and one which requires a fee, and the parent chooses the activity involving a fee.

What are the benefits of participating?

- Supports families in your community with access to high-quality and affordable care
- Enables access to Colorado Shines Quality Improvement funds
- Provides payment on a consistent reimbursement schedule
- Offers stable funding in times of natural disaster

Universal Preschool (UPK) Colorado

What is it?

<u>Universal Preschool (UPK) Colorado</u> is a state-funded program. It allows families to choose the right setting for their child, whether it is in a licensed community-based, school-based or home-based preschool setting. Families of children in the year before they are eligible for kindergarten, and qualifying 3-year-olds, are able to apply for UPK Colorado.

What are the program requirements?

To participate in UPK Colorado, all providers must be licensed and must sign a provider service agreement. Please contact your Local Coordinating Organization (LCO) for more information. You can find your LCO here. You can also find Provider FAQs on the UPK website.

How do I apply?

Providers can sign up to participate by visiting this link. Contact your LCO for more information.

What if I'm selected?

Providers will participate once they have registered and created a profile within the UPK Colorado system. When families apply, they rank their top five programs. Children are matched with programs using a mathematical algorithm with priority at each program given to returning students, siblings of currently enrolled students, and children of employees. The algorithm takes these priorities and families' preferred programs into account and finds the best possible match for each child. When the matching process is complete, providers are given a list of children that were matched to their program. Once families accept their provider match, they begin the enrollment process with the provider.

How are providers paid?

UPK payments for 4-year-olds are distributed to providers in advance on a monthly basis from August through May. Provider rates vary by location. To view the provider rates, click here.

What are the benefits of participating?

- Increases school readiness for Colorado children
- Increases equity in access to early care and education programs

Head Start Suite of Services

What is it?

Head Start programs support children's growth from birth to age 5 through services that support early learning and development, health, and family well-being. Head Start staff actively engage parents, recognizing family participation throughout the program as key to strong child outcomes.

Head Start services are available at no cost to children ages birth to 5 in eligible families.

- Head Start preschool services work with families with children ages 3 to 5.
- Early Head Start services work with families with children ages birth to 3, and many also serve expectant families.
- Early Head Start-Child Care Partnerships weave the Early Head Start program principles into licensed child care settings such as homes and centers, promoting a mixed delivery system.
- Migrant and Seasonal Head Start (MSHS) programs serve children ages birth to 5 from families engaged in agricultural work, either seasonally or across geographic regions.
- American Indian and Alaska Native (AIAN) Head Start programs serve children from federally recognized tribes and others in their communities.

Many local programs operate both Head Start preschool and Early Head Start services. Programs deliver child development services in center-based, home-based, or family child care settings. All Head Start programs continually work toward our mission for eligible children and families to receive high-quality services in safe and healthy settings that prepare children for school and life.

The federal government chooses grantees in each state to run the programs. Those grantees then directly run their sites and/or contract with existing providers to do so.

What are the program requirements?

- Comply with the Head Start Program Performance Standards
 - NOTE: The standards include requirements related to all aspects of a program, including teacher qualifications, ratio and group size, curriculum, professional development, screening and assessment and transitions. As part of the Early Head Start-Child Care
 Partnership, the grantee organization will help a community provider reach these standards through technical and financial support.

How do I apply?

If you are interested in offering one of the Head Start services, email the CDEC Head Start Collaboration Office (HSCO) at cdec_headstartinfo@state.co.us and they can connect you with any organizations that work with providers in your area.

What if I am selected?

The grantee will determine how many slots to provide to you. Each Early Head Start-Child Care Partnership slot is for a full day and full year of programming. The model is designed for you to have a class with some Early Head Start slots and other children funded through other means. This program supports access to a mixed delivery system.

The grantee will complete eligibility determinations of children and help families enroll in your program. They will also provide ongoing support to ensure you meet the program standards and are able to provide a high quality experience.

How are providers paid?

 Payment is based on a predictable contract for slots model where funds are provided by slot and not by attendance

What are the benefits?

- Helps provide quality early education and access to comprehensive services to vulnerable children in your community
- · Provides professional development and quality improvement support
- Offers providers a stable source of revenue and support with child enrollment

Military Child Care Fee Assistance Programs

What is it?

The <u>Military Child Care Fee Assistance Program</u> is the child care subsidy program for military families operated by Child Care Aware of America. There are two programs to subsidize the cost of ongoing child care that child care centers can participate in:

- Operation Military Child Care (OMCC), for families of deployed Army or Army National Guard members during their deployment, or
- Military Child Care in Your Neighborhood program, for families of Active Duty Service Members and full-time employees that cannot access on-post child care.

These programs are best suited for providers who operate in communities where families will be eligible - i.e. near a military base.

What are the program requirements?

Family child care providers must:

- Have a child care license;
- Have a state child care licensing inspection in the last 12 months free of disqualifying incidents;
- Complete an FBI and state child abuse and neglect registry background check;
- Meet eligibility criteria outlined by the military; and
- Be rated Colorado Shines Level 3 or higher pursuant to the <u>Military Child Care Plus Program</u> OR demonstrate high quality through one of the following methods:
 - A Child Development Associate (CDA) credential awarded by the Council for Professional Recognition
 - · Associates degree (AA) or higher in Early Childhood Education or Child Development
 - National Association for Family Child Care (NAFCC) Accreditation.

How do I apply?

The exact process to apply and all required documentation, including the application, can be found on <u>Child Care Aware of America's website</u>. Both an <u>online application</u> and <u>paper application</u> are available. Once your application is received, you will be notified within 7-10 business days as to whether you qualify for the program.

What if I am selected?

Providers that are approved for the program are listed on child care search websites specific to these military programs. Here is an example. Similar to CCCAP, if an eligible family selects you as their provider, you will receive an Approval Certificate, which indicates the authorized length of care and the amount covered by the subsidy, as well as attendance sheets that must be completed each month for payment purposes.

How are providers paid?

Providers receive the subsidy payment as a reimbursement that is based on completion and submission of attendance sheets. Each branch has different policies for payment, but a good overview of the general requirements can be found here. Here is an example of the payment policy for the Navy and Air Force. As with CCCAP, parents also pay a copay amount directly to the child care provider.

What are the benefits?

Local Preschool Programs

What is it?

Certain communities around the state use local dollars to create additional tuition credit/assistance programs to cover part of the child care cost for their families. Often, these programs are funded by community-based mill levy, or another local tax structure, and focus on supporting the cost of care for three- and four-year-old children.

Typically, a family is approved for the tuition credit and then chooses a provider based on the locality's criteria. Criteria for a provider to be eligible to take the tuition assistance varies from community to community. Additionally, application, selection, and payment processes will vary. You can read more about the requirements of these known local preschool programs:

As communities continue to recognize the importance of affordable, quality child care for their families, the list above is likely to grow. You can always check with your local Early Childhood Council to see if a local preschool program is available in your area.

Covering the Cost of Food

All licensed family child care homes are eligible to participate in the Child and Adult Care Food Program (CACFP). Participating in CACFP makes good business sense for a few reasons. First, it offers reimbursement for the nutritious meals you serve your children. This lowers your expenses and allows you to reinvest those savings in other parts of your program. Second, offering low or no-cost healthy meals to the children and families you serve is a good way to market your program to families. Read more about all the benefits of the CACFP for family child care home providers here.



Child and Adult Care Food Program (CACFP)

- Availability: Statewide
- What: Federally-funded program that provides reimbursement for nutritious meals and snacks served to children in participating programs thereby supporting the health of the children while reducing provider costs. Read about the <u>benefits of participating in CACFP</u> and visit the Colorado CACFP cost-benefit tools for <u>homes</u> to see how much money you might receive.
 - Most-recent reimbursement rates can be found by clicking on the "Rates Table" found here.
 - Family child care homes might explore <u>Farm to Child</u> through CACFP so they can buy food from local farmers or grow their own food. Participating in Farm to Child can help build the provider's connection to the community which could lead to more resources like grants or donations.
- **How to Apply:** Family child care home providers can apply for the program through a <u>local</u> Colorado CACFP Sponsor.

Grant Funding for Child Care Programs

Entities like the Colorado Department of Early Childhood, foundations, and local organizations may offer grants to child care providers beyond those listed below. Local <u>Early Childhood Councils</u> have information about these opportunities.

Colorado Department of Early Childhood Funding

- Colorado Shines Quality Improvement (CSQI) Capital Improvement Grants
 - Purpose: Help programs seeking quality improvement with construction costs.
 - Amount: up to \$7,500.
 - Eligibility: Programs that are participating in the Colorado Shines QI Grant, also have the opportunity to seek minor improvement grants to make program improvements.
 - Requirements: Must sign Memorandum of Understanding, or agreement, with their ECC;
 reach a minimum of a Colorado Shines Level Two; and accept CCCAP (subsidy)
 - Availability: ongoing (as funding is available) but programs may only apply once.

A list of additional, time-limited grants from the Colorado Department of Early Childhood can be found in Appendix 2.

Other State Funding

- Small Business Administration
 - Informational webinars linked on the website above.

 - Paycheck Protection Program (PPP) Loans information on how to apply for a loan, and how to qualify for loan forgiveness
- Department of Local Affairs (DOLA) Grants
 - Community Development Block Grant (CDBG) Eligible uses of funds include acquisition, design/engineering, construction, reconstruction, rehabilitation or installation of public improvements or public facilities.
 - Municipalities have to be the recipient, but grant recipients could partner with child care programs for services.
 - Rural Economic Development Initiative
 - Counties with fewer than 50,000 people and communities with fewer than 25,000 people.
 - Projects that will be funded include plans, construction, programs, and capacity building.
 - Funding categories: job creation and retention, capacity building, economic resilience, and supporting entrepreneurial ecosystems.
- United States Department of Agriculture (USDA) Rural Development Program

- Community Facilities Direct Loan and Grant Program
 - Public bodies, community-based non-profit corporations, and federally-recognized tribes are eligible.
 - Rural areas with no more than 20,000 residents are eligible (according to US Census Data).
 - Community support services such as child care centers, community centers, fairgrounds or transitional housing.
 - Low interest direct loans, grants, and a combination of grants and loans are available.
- Business and Industry Loan Guarantees
 - For-profit businesses, non-profits, cooperatives, federally-recognized tribes, public bodies are eligible for loans.
 - Rural areas outside of a city or town with a population of fewer than 50,000 people.
 - Can be used for:
 - · Business conversion, enlargement, repair, modernization or development.
 - The purchase and development of land, easements, rights-of-way, buildings or facilities.
 - The purchase of equipment, leasehold improvements, machinery, supplies or inventory.
 - Debt refinancing when refinancing improves cash flow and creates jobs.
 - Business and industrial acquisitions when the loan will maintain business operations and create or save jobs.

Non-State Funding

- Buell Foundation
 - Application deadlines three times per year.
 - Provides funding in a range of areas, including capital improvements and quality improvement.
 - Providers should follow the application guidelines.
- <u>Early Childhood Council Leadership Alliance (ECCLA): Family Child Care Homes Facilities</u>
 Improvement Grants
 - Application deadlines twice per year
 - · Available for facility improvement funding for licensed family child care homes.
- Early Childhood Health Outdoors (ECHO)
 - Applications are posted on the above site as opportunities open up and are promoted through local Early Childhood Councils and Healthy Child Care Colorado.
 - Centers are eligible to apply to be Demonstration and Seed Grant Sites. The above site also includes information on free training and incentives for family child care homes.
 - Available to support improving the quality of outdoor spaces
- Healthy Child Care Colorado Capital Improvement Grants
 - Application deadlines twice per year.
 - Provides funding for capital improvements for either indoor or outdoor projects to 501(c)(3) organizations serving children younger than 5.
- History Colorado
 - Public entities (county, city, school district, etc.) and non-profit organizations are eligible for funds
 - Projects must demonstrate strong public benefit and community support
 - Preservation projects include: restoration and rehabilitation of historic buildings, architectural assessments, archaeological excavations, designation and interpretation of historic places, preservation planning studies, and education and training programs.

Software to Help Your Business

It can be difficult for a small child care business to pay for back office support or software to address attendance tracking and billing; finance; human resources; procurement; or other business related operations. The Opportunities Exchange has created models and resources for "staffed family child care networks" for family child care homes with such business needs and bulk purchasing. Federal stimulus grants will fund family child care navigators to also assist with child care licensing, quality, funding opportunities, and more.

Training Requirements

Training Options and Career Pathways

The training requirements for family child care home providers to begin operation and to continue operating can be found on this chart. Beyond what is required, ongoing professional growth is an important part of a successful family child care home business. The Colorado Shines Professional Development Information System (PDIS) provides a large catalog of online, on-demand, free learning opportunities on a variety of topics. Courses completed on PDIS can count toward annual professional development hours required in licensing. If you are having trouble with viewing trainings on PDIS or uploading training documentation, contact the PDIS Help Desk: cdec_pdishelp@state.co.us or 844-447-4441 Option 2.

If you are interested in additional low-cost trainings for working with infants and toddlers, the Expanding Quality in Infant Toddler Care (EQIT) Initiative is a great option for you as a professional. Please note that EQIT is required for large family child care home licenses, three under two family child care home licenses, infant/toddler family child care home licenses, and experienced family child care home licenses.

Additionally, if you are considering becoming a coach or having some other role in the early childhood system, <u>MyColoradoJourney.com</u> is a resource for mapped pathways in the early childhood field beyond operating a family child care home.

Professional Development, Higher Education, and Coaching Funding

Trying to find the funds for professional development outside of PDIS can be challenging. This section provides information about resources and programs that support professional growth for yourself and your staff (if applicable), without breaking your budget.

- Colorado Shines Quality Improvement Grants
 - Run by the Colorado Department of Early Childhood
 - Purpose: For quality improvement expenses, including coaching, professional development and/or early learning materials.
 - Amount: Varies based on program size, up to \$3,500.
 - Eligibility: All licensed early childhood programs willing to enhance quality through engagement with the <u>Colorado Shines Quality Rating and Improvement System</u>.
 - Requirements: Must sign Memorandum of Understanding, or agreement, with their Early Childhood Council.
 - Availability: Ongoing (as funding is available). Programs can reapply each year.
- <u>Teacher Education and Compensation Helps Early Childhood® Initiative</u> (T.E.A.C.H. Scholarship)
 - Administered by the Early Childhood Council Leadership Alliance (ECCLA)
 - Can help supplement costs to become early childhood teacher-qualified, director qualified, or to obtain an associate or bachelor's degree.
 - Has certain work requirements depending on the pathway.
 - May have income requirements for eligibility.
- Early Childhood Council Leadership Alliance (ECCLA) Scholarships and Grant Opportunities:
 - Several scholarship and grant opportunities for students who would like to earn a degree or certificate in early childhood education
- Workforce Innovation and Opportunity Grants
 - Run by the Colorado Department of Labor and Employment or CDLE
 - Funding for certain early childhood certificates.
 - Must attend one of the designated programs to receive funding (certain colleges and training programs are approved).

Early Childhood Mental Health, Child Care Health Consultants, and Farm to Early Childhood

Directors, early childhood professionals and caregivers of children age birth to six are eligible to receive no cost support and training on-site at the child care program, remotely or at another convenient location.  - Benefits of participation include improved classroom or other learning and care environments, reduced incidents of behaviors adults find challenging, increased understanding of typical child development, and reduced caregiver stress and teacher turnover. Working with a consultant can help increase staff retention and reduce the likelihood that a child will leave a program.
